Subject: Amendment to the Tender Document for International Tender No. TSS/FP/TSS Meter Plant/2010/12, dated 19/09/2010.

Reference: Amendment No. 1, dated 09/10/2010.

Dear Sirs,

The following amendments have been made against the subject mentioned tender.

1. Replace the Clause 16 (Page 4 of 32) with the following:

Shipment of all items is to be completed **within 60 (sixty) days** from the date of opening of the Letter of Credit (LC). All Machine/equipment/Tools under this tender is to be supplied, installed, tested and commissioned in all respect and handed over to TSS for its commercial operation by the manufacturer's in TSS Plant within 30 (thirty) days after receiving at the Plant by TSS or **within 90 (ninety) days after opening of the LC**, whichever is earlier.

2. Add the following line at the end of the Clause 18 (Page 4 of 32).

TSS will nominate 2 (two) persons from the Meter Plant for the PSI.

3. Replace the Clause 22 a (Page 5 of 32) with the following:

Minimum **2 (two) years** warranty shall be provided for all the equipments from the date of final acceptance by the TSS Meter Plant.

4. Replace the last two sentences of the Clause 24 (Page 6 of 32) with the following:

The PG shall remain valid for minimum **2 (two) years** from the date of final acceptance by TSS Meter Plant, and it will not accrue any interest in favor of the Contractor or the Manufacturer.

5. Add the following after the last sentence of the Clause 39 (Page 8 of 32):

The training may be conducted for **2 (two) persons** of TSS Meter Plant during the PSI for a period of 5 (five) days according to the requirement. The local training at the TSS Meter Plant by the appropriate engineers/technicians of the Manufacturer(s) shall be conducted for a period of minimum 1 (one) week or as appropriate and fixed by mutual discussions.

6. Replace the Table of the Clause 46.4.1 (Page 11 & 12 of 32) for the three phase meter test bench with the text and table (3 pages) attached as **Annexure – A**.

7. Replace the Clause 48 (Page 15 of 32) for the Burden & Puncture Test Bench with the text (1 page) attached as **Annexure – B**.

8. Add the following items as a lot (Meter Components) after the item no. 4 of the Price Schedule of the Part – IV (Page 19 of 32):

The prices for lots and items will be evaluated separately. The technical data and specification of meters are attached as **Annexure – C1** (three phase meter), **Annexure – C2** (single phase meter) and **Annexure – C3** (single phase Pre-paid meter). For convenience of having the proven final products, preference will be given to the bidders who will quote prices for all the items.

9. Replace the last sentences of the Second Para of Annexure – 4 (Page 24 of 32) with the following:

If within 5 (five) years from the date of delivered to and accepted at the final destination the assembly plant of TSS at Gazipur, Bangladesh, the purchaser discovers any defects in workmanship and or materials and notifies the supplier/ manufacturer in writing then the supplier shall with all reasonable speed remedy such defects of non-conformance to the specific action at his own expense by adjustment, repair or replacement at the option of the purchaser, and in such case the warranty period shall be extended by 2 (two) years from the date of repair/replacement of the defective item.

10. Replace the last sentences of the Second Para of Annexure – 5 (Page 25 of 32) with the following:

If within 5 (five) years from the date of delivered to and accepted at the final destination the assembly plant of TSS at Gazipur, Bangladesh, the purchaser discovers any defects in workmanship and or materials and notifies the supplier/ manufacturer in writing then the supplier shall with all reasonable speed remedy such defects of non-conformance to the specific action at his own expense by adjustment, repair or replacement at the option of the purchaser, and in such case the warranty period shall be extended by 2 (two) years from the date of repair/replacement of the defective item.

Please note that all other terms and conditions of the Tender Document shall remain unchanged.
